

## FEDTECH, INC. TERMS AND CONDITIONS

CREDIT TERMS: Payment will be due prior to release of parts unless a credit application is approved.

Upon approved application for credit, credit terms are Net 30 days from the date of invoice unless otherwise agreed upon in writing. Fedtech reserves the right to adjust

payment terms per Fedtech management's discretion.

ORDER If an order is cancelled by the customer, a cancellation fee will be charged and is fully

CANCELLATION: payable by the customer. The cancellation fee will include charges for all materials

ordered and work in progress at the time of cancellation. The minimum order

cancellation fee is \$25.00.

CREDIT LIMIT: Fedtech reserves the right to assign an initial credit limit to your account. If this does not

suit your needs, please contact the Accounting Department regarding your limit.

LATE FEES: Fedtech reserves the right to charge a minimum late fee of 1.5% monthly (18% annually)

on all invoices that are not paid within 30 days of invoice date.

COLLECTIONS: If an attempt to pay is not made before an invoice reaches 15 days past due, Fedtech,

Inc. has the opportunity to turn your account over to the collection service of its choice. If collection does occur, the debtor will pay all attorney's fees accrued by the creditor

during the collections process and an interest charge of 18% on all invoices turned over

to collections.

CREDIT INVESTIGATING Fedtech, Inc. may investigate your credit and verify your credit references. We may also AND REPORTING: report to credit reporting agencies and other creditors the status and payment history of

your account, including any negative credit information. You also authorize us to investigate your credit history by obtaining consumer credit reports and making direct inquiries of businesses where you have accounts. We may inform the company for which

your account is issued and its licensees of information regarding your account, including

credit limit.

LIABILITY / CLAIMS

AND DISPUTES:

LIMITATIONS OF In the event of a claim or dispute, the limit of liability for Fedtech, Inc. would be the cost of repairing and/or replacing the non-conforming product or the value of the contract. In no event shall Fedtech be liable for damages exceeding the purchase price to be paid to

> Fedtech per the contract. Any claims or disputes are required to be reported in writing within 5 business days from receipt of goods. Fedtech reserves the right to grant

customers a longer dispute window upon Fedtech's discretion.

CHANGE OF ADDRESS: If you change your address, you must provide Fedtech, Inc. with your new address within

15 days.

SALES TAX: Appropriate state tax will be added to your invoice when applicable unless you provide

Fedtech, Inc. with a Tax Exemption Certificate that is accurately and completely filled

out.
